

Women Empowerment Through SHGs

Empowerment is a process of sensitizing about social realities and existing rights, to develop capacities through education, knowledge, skills and facilitating participation to bring a positive change. Self Help Groups provide women a chance to participate in social, economic, and political activities through its various programmes, develop their decision making capacity, increase savings, and enhance their social mobility. Presently we have 503 women SHGs functional at ESSS with a total membership of 10060. These groups are working under 66 federations.

International Women's day Celebration

International Women's Day falls on March 8 every year. This year we had celebrations at region level. So we had 5 programmes arranged under the leadership of Village Organizers and Federation/SHG leaders. Many dignitaries from PRIs and Government departments including MPs and MLAs inaugurated the Women's Day celebrations in each region. Around 13,000 women delegates were the attendees of these celebrations. Each programme ended with cultural programmes and sumptuous lunch.

Paper Challenge for Women SHG Federations

A Paper Challenge for women SHG federations was organized on the sideline of International women's Day celebration. The core idea of the programme is to raise funds for Asakiranam Cancer Care Campaign and Archbishop's Snehabhavanam Project. The funds collected towards Asakiranam Cancer Care Campaign from 8 regions are Rs. 3,56,136,- The funds raised towards Archbishop's Snehabhavanam Project are Rs. 17,180/-. The highest contributed federations were rewarded with ever-rolling Trophy and Memento.

Empowering Men Through Self Help Groups

ESSS promotes SHGs for Men since 2003 to build up their skills and confidence and increase their income. The groups offer both financial and social support to empowerment through a strong network of allies. Presently 440 Men SHGs are functional at ESSS with a total membership of 7500. The groups work under 28 federations.

Empowering Unorganized Workers through Labour Department

The Labour Department of ESSS is workers-friendly. Trade Unions of unorganized workers are functioning with the support of Kerala Labour Movement(KLM), the Official organ of KCBC Labour Commission working for the betterment of unorganized workers in Kerala. It aims at facilitating and advocating decent work condition for the unorganized workers. It also promotes Social Security Schemes, Capacity building of workers, skill development, promotion of alternate livelihood, campaigning for basic rights of workers etc..

Various Fora functional @ ESSS

1.Kerala Tailoring Workers Forum (KTWF)

It aims at organizing tailoring workers by enrolling them in the Kerala Tailoring Workers Welfare Fund. Total Membership – 5563.

3. Kerala Domestic Workers Forum (KDWF)

Domestic workers are given a platform to come together for capacity building and they are enrolled in various schemes available for their social security. Total Membership – 1493.

2. Swathanthra Nirmmana Thozhilali Union(SNTU):

It helps to empower those persons who are working in construction sector.
This group also is given chance to enrol in Social Security Schemes.
Total Membership – 1579.

4. Unorganized Workers Forum(UWF):

Under the newly invented Kshemanidhi, any worker who is considered as unorganized could join and accept benefits as per norms.

5. Kerala Matsya Thozhilali Forum(KMTF):

Total Membership - 126.

May Day Celebrations and Forum Anniversaries.

May Day celebrations are conducted in central and regional levels to strengthen the social and economic advancement of workers. Seminars and public meetings were conducted together with Flag Day observation. Each forum celebrates its Annual Day with various programmes and initiatives.







Micro-Enterprise Development Programme

The main thrust of ESSS is to empower the SHG members to enable them to undertake incomegenerating micro enterprises on a viable and sustainable basis. For this ESSS focus on identifying and mobilising aspiring entrepreneurs and capacitating them through entrepreneurial, vocational and life skill development.

ASAKIRANAM CANCER CARE CAMPAIGN

ESSS join hands with Caritas India in assisting cancer patients through various initiatives. The local fund mobilization is the key component of the campaign. Cancer awareness, Financial aid, Medical and psychological support, Hair donation Camps, Waste management awareness and Promotion of organic farming make this campaign remarkable.

Important Activities

- Collected Rs. 13,14,700/-through various fund raising programmes.
- Provided a financial assistance of Rs. 12,00,000/- to 240 cancer patients.
- Cancer Detection Camps in association with Sucheendra Medical Mission and Karkinos.
- Organized Cancer Survivors Meet.
- Cancer awareness for the general public especially SHG/Federation members.
- Organized Hair Donation Camps and distributed wigs to the patients.
- Nutritious Food Kits and Blankets to cancer patients in General hospital.
- Trained a group of volunteer to care cancer patients.

DIALYSIS CHALLENGE – For Kidney Patients

Mr. Hibi Eden, MP, had a dream of caring kidney patients in Ernakulam Parliamentary constituency and he approached ESSS to be the partner of the programme named "Dialysis Challenge". We have a linkage programme with some hospitals situated in Ernakulam city and they provide dialysis at a subsidized rate of Rs. 750/-. So far we have reached nearly 500 kidney patients and provided the financial assistance of nearly Rs.8,00,000/-. Special gratitude and appreciations to Mr. Hibi Eden.

ARDRAM PALLIATIVE CARE & HEALTH CLINIC

Our palliative care services provide comprehensive support to bedridden patients and their families. Health clinic is mainly utilised by the elders of House of Providence.



Family Development Programme

Save A Family Plan – India

It is a sponsorship programme for 300 vulnerable families. The poorest of the poor families are selected based on predetermined criteria and provide financial assistance for 6 years. Apart from this, the project will encourage the families to viable income through sustainable livelihood initiatives. Meetings are conducted in Central and regional levels. The families are called at regular intervals for planning the activities and evaluating their performance in this programme.

SAYAMPRABHA - Elders Self Help Groups.

ESSS promotes Sayamprabha Groups of Elders since 1992 to provide psycho-social support to senior citizens above 60 years of age. The groups are instrumental for personal sharing and emotional ventilation. Elders are encouraged to start viable livelihood initiatives and it provides an opportunity for their inter-generational bonding and collective action.

. HOPE & HELP - Rehabilitation of Differently-Abled.

The programme provides a sustainable livelihood opportunity and rehabilitation of the differently-abled persons from the poor social and economic background with the support of REHASWISS. ESSS is engaging the persons with disabilities with specific skills to enable them to lead a dignified and independent life. In current reporting period, we provided financial support to 21 families to start income generation programmes.

Major Programmes conducted.

- Observance of International Day of People with disabilities on December3.
- Skill training Programmes for the differently-abled and their family members.
- Conducted Awareness class on Insurance and other Social Security Schemes.
- Organised sensitisation on Project Activities.



Micro Insurance Schemes

ESSS joins hands with different national insurance companies to promote medical insurance, life and death insurance and insurance to our assets.

Important Policies promoted

- Universal Health Insurance Policy(Medi-Claim Policy): Implemented in association with United India Insurance Company. The maximum coverage of the policy is ₹ 1,00,000/- A total of 3889 families and 7397 persons were insured under the policy and ₹ 1,34,99,090/- is paid to the company. Total Benefits received is ₹ 1,04,04,226/-
- 2. Critical Illness Policy(Flexi Floater Group Mediclaim Policy): Implemented in association with New India Assurance Company Ltd.for providing insurance coverage for 8 major illnesses. The maximum coverage of the policy is ₹ 2,00,000/- A total of 430 families and 1136 persons were insured under the policy and ₹ 12,25,397/- is paid to the company. Total Benefits received is ₹ 12,84,947/-
- Griha Suraksha: Designed to protect the residential houses against calamities.
- 4. GI (Group Insurance) Policy: Promoted by Life Insurance Corporation of India. A person in the age group of 18-59 can join and the nominee will get the death benefits. A total of 1974 persons were insured under the policy and ₹ 4,29,400/- is paid to the company. Total Benefits received is ₹ 4,50,000/-
- Swavalamban: Designed to make senior citizens of the unorganized sector financially secure and independent by the Government of India.
- 6. Jeevan Madhur: A simple savings scheme with insurance plan.
- 7. Students Uni-Study Insurance: This scheme is named as Servant of God Archbishop Joseph Attippetty Memorial Insurance for students. The yearly premium is only ₹ 120/-. The benefits are manifold. A total of 2357 students were insured under the policy and ₹ 4,29,400/- Is paid to the company. Total Benefits received is ₹ 5,05,491/-
- Prime Minister Suraksha Bhima Yojna: Central Government scheme for accidental death and the disabilities repair. The annual premium is ₹ 20/-Sum assured is ₹ 2,00,000/-
- Prime Minister Jeevan Jyothy Bhima Yojna: Central Government scheme for the natural death.
 The annual premium is ₹ 436. Sum assured is ₹ 2,00,000/-
- 10. Sukanya Samrithy Yojna: Central Government scheme for girl children. Beti Bachao Beti Padhao is the slogan – The protection and education of girl children.







Thematic Area - IX Basic Infrastructure Development

Archbishop's Snehabhavanam Project

This project is to support poor and marginalised families irrespective of their caste and creed to complete the construction of the houses and hence to help them to achieve their dream of a safe house. The project is supported with parishes, well-wishers and SHGs. In this current reporting year, ESSS supported 172 families in this project and provided a total assistance of Rs. 32,40,000/to the beneficiary families.

Our warm regards and respectful gratitude to His Grace Archbishop Joseph Kalathiparambil for his immense support and humility in raising funds for this project.





Thematic Area - X Environment and Natural Resource Management

ESSS focus on a sustainable environment and natural resource management programme. ESSS is committed to UN sustainable development goals and is significant to protect the mother earth. ESSS upholds green protocol as a strategy to ensure a sustainable world for all. Promotion of water conservation, organic farming, kitchen/terrace gardens, renewable energy sources and social forestry are core to this programme.

It is a financial institution registered under Indian Company Act. It is closely monitored by Reserve Bank of India. We are having Saving Scheme up to 5 years for the women folk. This scheme assists the women to ensure their financial security and life sustainability. It is a new venture ESSS started in 2021.

Major Components

- Saving scheme for women.
- Various loans with certain securities.
- Death Benefit Scheme.





Thematic Area - XII

Legal Services

Community Mediation Centre

It is an alternative dispute resolution mechanism proposed by the Supreme Court of India to offer speedy redressal of grievances to litigants. In ESSS it was established with the support of the High Court of Kerala and Kerala State Legal Service Authority. The core idea of the programme is to ensure speedy justice to affected parties with effort of the neighbouring community in cases related to civil nature. Each centre has the service of trained mediators and they will mediate between the affected parties to settle disputes amicably.

Thematic Area – XIII

Animation

The animation is a systematic process to improve the knowledge, skills, understanding, values, motivation and capabilities of employees, village organizers, SHG/Federation leaders and volunteers. The positive impact of capacity building affects organizational outcome, competitiveness and performances.

Main Activities

- Darsan: The Capacity building and Leadership Skill Development programme for Social Ministry Coordinators.
- Capacity Building of Staff.
- Village Organizers' zonal and review Meetings.
- Capacity Building sessions in central and regional levels for SHG/Federation leaders.



Empowerment of Children Through Kuttikoottam

Kuttikoottam (Children's Nature Club) provides a platform for poor and marginalised children in the age group of 5 – 17 years for their overall development. The groups will conduct a periodic meeting with the supervision of Kuttikootam animators. At present 68 Kuttikoottam groups are functional at ESSS.

ESSS works in partnership with families, schools, churches and SHGs to ensure the holistic development of children irrespective of their caste, creed and religion.

Major Components

- Formation and strengthening of Children's Nature Clubs.
- Campaign against Drug Menace.
- Facilitates opportunities for children's career and scholastic development.
- Provides life skill education.
- Promotes the message of environment protection.
- Classes on personality development.
- Organizing leadership camps during vacation.
- Conducting various competitions for children.





JEEVAJYOTHI – Value Based Training Programme

The programme was organized by Prof. Monamma Kokkad, the member of Minority Commission. It was a one-day training programme led by Mr. Jomet John, a groomer of children in various capacities. Prof. Monamma inaugurated the training programme. Nearly 85 children participated in this training session. The topics dealt with were personality development, positive attitudes, confidence building and leadership skills.

ESSS - DP World Centre For Learning

It is a new venture ESSS started during this financial year with the CSR fund availed from DP World, Kochi. Three class rooms are well furnished to train three trades – Tailoring Skills, LED Accessories Assembling and Paper Bag Making. All these trade courses are being run without any disruption.













Internship 2022 -2023

The Internship programme at ESSS Ernakulam provided students from various colleges with a unique opportunity to gain both theoretical and practical experience in Social work scenario. Theoretical and infra – structural orientation and training programmes are given in the ESSS centre. The practical social work – field work activities are arranged in the way of Community organisation, Group work – Case work Activities among groups such as women SHGs – M. SHGs – Kuttikkoottam – Sayamprabha etc., Social work clinical experience at Aswas counselling centre, Geriatric experience at Geriatric centre of Providence Road, Palliative care social experience at Vypeen, Educational Social work among special Schools at Kakkanad and Vadel etc. Over the course of Internship interns were immersed in hands on projects, workshops, community engagement initiatives and social action at society aimed at addressing the Vision and Mission of the NGO.


